FY23 Half-Year Results and 1.40 Cents per Share Fully Franked Quarterly Dividend Declaration

The Board of NAOS Ex-50 Opportunities Company Limited (ASX: NAC) (Company) is pleased to announce that it has declared a fully franked quarterly dividend of 1.40 cents per share for the 3 months to 31 December 2022, bringing total dividends since inception to 41.95 cents per share, all of which have been fully franked. The Company also released its half-year results for the period ended 31 December 2022, recording an after-tax loss of \$446k. For the half-year to 31 December 2022 the Company delivered a total shareholder return of +2.34%, which was reflective of the narrowing of share price discount to NTA over the period. This measure does not include the benefit of franking credits received by shareholders.

Since inception to 31 December 2022 the investment portfolio has returned +9.67% p.a., outperforming the benchmark S&P/ASX 300 Industrials Accumulation Index by +3.22% p.a. NAOS Chief Investment Officer and Managing Director Sebastian Evans stated: "The first six months of the financial year has been dominated by inflationary concerns, but we are optimistic that when demand returns for emerging companies, there will be the potential for significant long-term gains. In volatile periods such as these, it is imperative that we continue to adhere to the same investment philosophy that has delivered significant outperformance over the longer term. This entails a high conviction investment approach with a core focus on investing in small to mid-cap industrial type businesses.

Fully Franked Dividends

The Company is pleased to announce a fully franked quarterly dividend of 1.40 cents per share, bringing total dividends declared since inception to 41.95 cents per share. It is the Board's aim to continue to be mindful of providing shareholders with a sustainable, growing stream of dividends over the long term, franked to the maximum extent possible. The Company's profit reserve as at 31 December 2022 is 48.4 cents per share.



Share Buyback

The on-market share buyback remained active throughout 1H FY23, with 249,567 shares bought back in the sixmonth period to 31 December 2022. Since the commencement of the buyback in June 2019, 11.6 million shares, or 22% of shares on issue, have been bought back on market, which has been significantly accretive for shareholders.

Shareholders can elect to participate in the Company's Dividend Reinvestment Plan (DRP).
